Understanding Your Bill

All medical procedures performed during your visit will have a separate charge to your insurance company **in addition** to your office visit. You will be responsible for paying what your insurance does not cover; this includes your deductible, coinsurance and copay. No part of your visit is considered a preventive benefit.

Some common medical procedures include:

- Freezing or chemical treatment of warts
- Freezing other skin lesions
- Cyst Drainage
- Steroid injections into the skin
- Skin samples (skin biopsy) and pathology lab fees
- Any surgical procedure and pathology lab fees

The following types of procedures are considered cosmetic and will be charged directly to you at the time of service, they are not covered by insurance:

- Acne or “little white bump” extractions
- Brown spot or age spot treatments
- Removal of any skin lesion or spot that is for cosmetic reasons
- Most laser treatments
- Skin tag removal
- Esthetician services

Special Note Regarding Lab Fees

- Any blood that is sent to an outside lab will result in a fee from the testing center
- Skin/tissue sent to the pathology lab will have a lab fee from Dermatology Consultants and a separate bill from Hospital Pathology Associates
 - Sometimes, additional testing is requested by the pathologist, this will result in additional fees
